Coming from the north: take Highway 101 heading south. In Ventura, take the Ventura Avenue exit (Exit 70A). Stay straight to go onto South Ventura Avenue. Turn right onto East Main Street. Turn left onto North California Avenue. Turn right to stay on North California Avenue. Turn right onto Poli Street. 501 Poli Street is on the left.

Coming from the south: take Highway 101 heading north. In Ventura, take the California Street exit (Exit 70A). Turn right onto South California Street. South California Street becomes North California Avenue. Turn right to stay on North California Avenue. Turn right onto Poli Street. 501 Poli Street is on the left.
